First Clinical Reference Group audit scoping

The NOCA Clinical Reference Group held its first meeting in September 2023; top of the agenda was the scope of the audit. The NOCA Project Team worked closely with stakeholders including NHS England, Public Health Wales, Ovarian Cancer Action, Target Ovarian Cancer and the British Gynaecological Cancer Society, to produce a scoping document which will be published in November on the NOCA website. This document outlines the 5 Quality Improvement goals that NOCA will focus on and will provide a basis for the NOCA Healthcare Improvement Strategy, which is planned for the first quarter of 2024, and will include detail on the quality performance indicators.

Also coming up in the first quarter of 2024 will be our first NOCA webinar where we will present initial analysis on the data. More details to come!

How are patient data being collected?

The audits in NATCAN, similar to the existing audits in prostate and lung cancer, do not 'collect' clinical data. The cancer audits utilise the nationally mandated flows of data from hospitals to the National Disease Registration Service (NDRS) in NHSE and the Wales Cancer Network in Public Health Wales. Each NATCAN audit will publish a minimum dataset in the Autumn of 2023, comprising relevant data items for each cancer which hospitals can check are site. beina completed and submitted to NDRS or the Wales Cancer Network.

Therefore, there is no need for NHS organisations to formally register for the audits, or input data on patients through a separate database portal. Additionally, there is no audit specific deadline for sites to submit the data.
